SECTION 5: FIREFIGHTING MEASURES**5.1 Extinguishing media:**

Product is non-flammable under normal conditions of storage, manipulation and use, containing flammable substances. In the case of inflammation as a result of improper manipulation, storage or use preferably use polyvalent powder extinguishers (ABC powder), in accordance with the Regulation on fire protection systems. A.- Precautions for safe manipulation
